



Call to order 5:15pm

- Discussion on CIP budget. Funding requests should include:
 - Designated staff person to coordinate climate activities across all staff and commissions.
 - Dedicated funds that can be used as matching funds for grant applications
- November meeting minutes approved.
- Review of correspondences
 - Task force members will host a table during the March 2nd Farmers' Market. Discussion on what are the important items to convey.
 - Review of FOIA correspondence.
- Tasking
 - CCTF vision for short- and long-term goals of Flood Prevention, Climate Resilience, and Erosion Control Board have been submitted.
 - Content for social media campaign has been submitted. Local students will begin to take this content and create posts.
 - Additional input on the zoning regulations, including regulations that incorporate resiliency and sustainability measures, is being requested.
 - First Selectmen will be the liaison for Sustainable CT. The Task Force will explore the Climate Action section.
 - Plan of Conservation and Development update is going well. Progress is being made but an external consultant may be needed.
 - Flood Prevention, Climate Resilience, and Erosion Control Board update and are decided if they should take on the function of the stormwater authority.
