4. Old Business

a. Discussion of Commission's Mission Statement

Moira made a motion to adopt the Mission Statement composed by Hannah Cedermark. Lynn seconded; all were in favor and Mission Statement was adopted.

The HOC's mission is to create a full range of housing opportunities in Stonington; support inclusive, integrated, and vibrant communities; and cultivate equitable and sustainable growth. (HC)
