- January meeting minutes approved.
- Review of correspondences
  - Review of FOIA correspondence.
  - Kristin Foster presented on Mason's Island Shoreline Project. Reviewed the feasibility study and potential of a living shoreline. Discussed funding associated with the construction of the project.
- Discussion on CIP budget. Funding requests included \$500,000 for resilience fund to serve as grant match. The \$245,000 request for EV charging stations was cut to \$20,000. Request to attend the next meeting to support these asks.
- Tasking
  - Zoning regulation update is continuing and a public meeting on the proposed resiliency and sustainability measures is scheduled for March.
  - Request for members to submit their ranking for the next round of priorities, prior to the next meeting.
  - Discussion on composting program renewal, plastic bag recycling, and alternatives to the pink bag recycling program.
  - Task force members will be hosting a table in early March at the Farmer's Market.
  - Assistance is requested to review the Sustainable CT Climate Leader qualifications.
  - Plan of Conservation and Development update is going well. Special meetings have been requested to further the process.
  - Flood Prevention, Climate Resilience, and Erosion Control Board update and are continuing the stormwater authority discussion.
