# Town of Stonington Conservation Commission Minutes of a Regular Meeting held on February 24, 2014 Police Station Community Meeting Room, 173 South Broad Street, Pawcatuck, CT

1. Call to order: Called to order by Vice Chairman Stuart Cole at 7:10 p.m. Commission members also in attendance were Walter Grant, Ben Baldwin and Tim Bell. Members Stanton Simm, Jim Friedlander, Sheila Lyons and Bob Dewire and Town Planner Keith Brynes were absent. Members of the public were present.

#### 2. Review of Town Developments and Proposals

2a. PZ1401SD & GPP Standard Oil Co. of South Minster (Craig White) - Subdivision application for a 3 lot re-subdivision of a 17.18 acre parcel. Property located at 248

New London Tnpk., Stonington. Assessor's Map 138 Block 3 Lot 10A. Zone GBR-130. The proposed Smoke House Estates re-subdivision calls for 3 lots served by one common driveway. Lot 1 is a rear lot of 7.93 acres with the existing residence and a guesthouse is also proposed for this lot. Lot 2 of 3.99 acres is a front lot with a house site near the intersection of Routes 184 & 201. Lot 3 is a rear lot of 5.98 acres. There was discussion on whether an open space set aside or fee in lieu of open space was required as it not mentioned on the plan or application. It was noted that the historic Whittlesey Cemetery (138-3-10B) is accessed via this property and that trees are not depicted on the plan.

MOTION: We ask when the original subdivision was granted and whether open space was set aside at that time. We see no notation of open space or a request for a fee in lieu of open space on the plan or application and ask if it is not required. We request deeded public access to the Whittlesey Cemetery (Bell, Grant). Passed unanimously.

**2b. Toll Brothers** – Discussion of pending open space dedication for previously approved Old Mystic Estates Subdivision currently under construction by Toll Brothers. Property located at Whitehall Ave., Jerry Browne Rd., & Pequot Trail, Old Mystic. Application #PZ0360SD, SUP & GPP. Not discussed as no new information has been received.
