The Special Town Meeting of the electors and citizens qualified to vote in Town Meetings of the Town of Stonington, Connecticut, will be held at Stonington High School, US Route 1, 176 S Broad St., Pawcatuck, CT 06379 on

To consider, discuss, and vote upon the following.

FIRST: To consider and vote on a resolution to adopt an Ordinance of the Town of Stonington, Connecticut, providing for the partial abatement of taxes for real property located at 26 Main Street, and owned by the Portuguese Holy Ghost Society. Said abatement would cap the property tax burden of the subject property to no more than \$7,500.00 for the current assessment year, and for every assessment year thereafter, up to and including the assessment year of October 1, 2019, at which time said abatement would be revisited by the Town. A copy of the complete text of the proposed Ordinance is on file in the Town Clerk's office during normal business hours.

SECOND: To consider and vote on a resolution to approve the Board of Finance's approval of a \$168,099 additional appropriation from the Undesignated Fund Balance to the Department of Public Works' Snow Removal account.

THIRD: To consider and vote on a resolution to authorize the Stonington Board of Education to apply to the Commissioner of Education and to accept or reject a grant for the Renovation/Extension at the West Vine Street School; to establish the Stonington K-12 Building Committee as the building committee with regard to the Renovation/Extension at the West Vine Street School and to authorize at least the preparation of schematic drawings and outline specifications for the Renovation/Extension at the West Vine Street School.

FOURTH: To consider and vote on a resolution to authorize the Stonington Board of Education to apply to the Commissioner of Education and to accept or reject a grant for the Renovation/Extension at the Deans Mill School; to establish the Stonington K-12 Building Committee as the building committee with regard to the Renovation/Extension at the Deans Mill School and to authorize at least the preparation of schematic drawings and outline specifications for the Renovation/Extension at the Deans Mill School.

FIFTH: To consider and vote on a resolution to authorize the Stonington Board of Education to apply to the Commissioner of Education and to accept or reject a grant for the roof replacement at the Pawcatuck Middle School; to establish the Stonington K-12 Building Committee as the
