PLAYGROUND SUPERVISOR

This position requires a self motivated creative team player to provide on-site administration for the Recreation Division's Morning Playground Program and the Youth & Family Services Division's breakfast, lunch and Afternoon Enrichment Program during the summer camp season. The program begins on June 18, 2015 and ends August 14, 2015 with 35-38 hrs/wk and/or 7-8 hrs/day M-F. This position includes additional hours prior to the start of the camp season for program preparation and daily curriculum development, as well as a mandatory training on June 13, 2015. Experience developing thematic curriculum and working with elementary age children in a youth camp environment is required. Bachelors Degree preferred. Minimum of 2 yrs supervisory experience is also required. Red Cross CPR Certification desired. Minimum age of 21yrs. Criminal Background check required. Please submit three letters of reference with application. The hourly range is: \$15.50-\$18.50/hr. based upon experience.

PLAYGROUND COUNSELOR

Motivated, high energy team players who enjoy working with youth are encouraged to join our team! The camp program begins on June 18, 2015 and ends August 14, 2015 with 20-35 hrs/wk and/or 4-7 hrs/day, M-F, including a mandatory training on June 13, 2015. Duties include: supervise and engage children; lead activities; and serve as a role model. Must have experience working with elementary age children. Minimum age of 16 yrs. Criminal background check required. A teacher reference is required with application. The hourly range is: \$9.15-12.50/hr. based upon experience. Breakfast and lunch included for Counselors age 18 and under.

PLAYGROUND JUNIOR COUNSELORS

High school students with an interest in gaining experience working with youth are needed! The camp program begins on June 18, 2015 and ends August 14, 2015 with 9-12 hrs/wk and/or 3-4 hrs/day days per week; including a mandatory training on June 13, 2015. This stipend position is designed to identify potential future Playground Counselors. Minimum age of 15yrs. A teacher reference required with application. Breakfast and lunch included, dependent upon assigned shift. The stipend is \$325.00-\$425.00 and paid at the end of the program.

GROUNDS MAINTENANCE

Experienced self motivated maintenance staff needed for summer field and playground maintenance. Position includes: 20-35 hrs/wk; 4-7 hrs/day, M-F; begin on May 1, 2015 and end August 31, 2015. Qualified applicants must be a minimum of 18 yrs old and demonstrate the ability to operate tractors, mowers and hand tools. Criminal Background check required. The hourly rate is: \$9.15-\$10.70/hr. based upon experience.
