- Athletic Fields ADA Accessibility – A motion was made by Mr. Simmons and seconded by Mr. Crouse to change the amount in FY 2015-16 from \$25,000.00 to \$50,000.00. Discussion: Mr. Simmons stated that years ago he worked for Senator John Chaffee of Rhode Island and he had a program of placing himself in citizen's situations to learn their job. Mr. Simmons stated that he went on a fishing boat, he worked in a jewelry store, he worked in a grocery store and he did a variety store. Mr. Simmons further stated Senator Chaffee was asked by a person with handicaps if he would sit in a wheelchair for a day. Mr. Simmons stated that he lasted an hour. Mr. Simmons also stated that his was in a wheelchair for ten years. He stated he stopped going to church and he stopped going to events. Mr. Simmons stated that his father became housebound because he didn't want be an embarrassment to his family and humiliate himself and so from his perspective ADA accessibility may seem unnecessary but try spending a day in a wheelchair.

A motion was made by Mr. Simmons, seconded by Mr. Crouse and voted unanimously to approve the above items.

**PUBLIC WORKS: HIGHWAY (CONTINUED)**

- Lg. Vehicle Overhead & Undercarriage Wash System – A motion was made by Mr. Simmons, seconded by Mr. Crouse and voted unanimously to change the priority from C to B.
- Permeable Surfaces Study for Town Parking Areas – as requested

A motion was made by Mr. Simmons, seconded by Mr. Crouse and voted unanimously to make the above items E, E, C priorities.

**PUBLIC WORKS: ENGINEERING**

- Climate Change Impact Study – change the priority from an E to a C and change the amount in FY 2015-16 from \$25,000.00 to \$10,000.00.

- Stonington COMO Floor Tile Replacement – a motion was made by Mr. Simmons, and seconded by Mr. Crouse and voted to approve this request. Mr. Crouse abstained. The vote was 2-0 in favor of the request.
- Public Restrooms at Town Dock – A motion was made by Mr. Simmons, seconded by Mr. Crouse and voted unanimously to change the priority from an E to a C.
- PNC Generator – as requested

A motion was made by Mr. Simmons, seconded by Mr. Crouse and voted unanimously to approve the remaining items in Public Works: Sanitation and Waste Removal, Public Works: Engineering and Outside Agencies items.
