### VIII. New Business

- a. Commission discussed the storage unit that is still in the same place that it was last time they talked about it. While it is a great place to store things – it is an eye-sore. The group then said he could be in charge of doing that and getting it moved.
- b. The sports fields:  
The fields were fertilized and the ground “plugged” last fall. It was supposed to be dragged but that was never done. It is all very rough and uneven. This process will be looked at with the new company they decide to go with to finish the fields. The work is going back to bid. The old company was not paid in its entirety. Commission does not feel it will be ready by baseball season.
- c. Kids have been seen on the fields that were seeded last fall. Need to get the word out to the kids that this could ruin the fields
- d. Fence:  
Fence falling down on the side of the school. Human Services Manager Leanne Theodore said she would look in to this and take care of it.
- e. Committee discussed the possibility of adding 35 parking spaces to the parking lot down by the tennis courts. People are parking on the grass to avoid having to park at the lot on the other side. Chair Crowley said it is not a priority at this time.
- f. Commission discussed the importance of an emergency plan for programs; there should be something solid in place for all programs.
