A special meeting of the Stonington Shellfish Commission was held on Thursday, September 11, 2014 at 7:00 PM at Stonington Town Hall, 152 Elm StreetStonington, CT. Voting members present wereMr. Alan Banister, Mr. John Swenarton, Mr. Don Raffo, Mr. Steve Brown; Secretary, Mr. Don Murphy; Chairman.

- 1) Call to order-Mr. Murphy called the meeting to order at 7:03 PM
- 2) Review and approval of the minutes of the regular meetings of August 7, 2014.

A motion was made by Mr. Banister and seconded by Mr.Swenarton to approve the August 7, 2014 regular meeting as presented. The motions were approved unanimously.

- b) Conditional Shellfishing Areas Outer Quiambaug Cove and East Mason's Island-All conditional areas and approved areas were-opened on August 21. Water testing of samples on August 27th from all areas had excellent results.
- c) Application by Toll Brothers, Inc. to install an outlet control structure and ppe from Whitehall Pond to an outfall at the Mystic River-no comment
- d) Application by Andre Maurice to construct a fixed pier, ramp, and floating dock in the Mystic River near Riverbend Drive-no comment
- e) Update on the re-stocking the conditional shellfishing areas. September 27th is the planned date for re-stocking the areas.
- f) Update on the pilot project to plant oyster seed Area B Oyster seeds will be planted on September 27th.
- g) Set the opening date, regulations and permit fees for the 20142015 scallop season A motion was made by Mr. Don Raffo and seconded by Mr. Banister to open the 2014-2015 scallop season on Saturday, October 112014 at sunrise and close at sunset on March 31 2015, maintaining current regulations and permit fees. The motion was aproved unanimously.

- i) Equipment update on trailer repairs. The trailer will continue to be housed at Don's Dock.
- j) Update on finances; collections, bills, and remuneration none to report
- k) Discuss the September 5, 2014 memo from Commissioner Reviczky (CT DoAg) regarding Connecticut Shellfish Bed Management Modernization Mr. Don Murphy plans to review the lease agreement and then brief the first selectman on the memo.
