TOWN OF STONINGTON SPECIAL TOWN MEETING February 26, 2024

A Special Town Meeting of the Town of Stonington was called to order at 7:03 p.m. on February 26, 2024 at the Stonington High School, by First Selectman Danielle Chesebrough. Also, in attendance were Selectwoman Deborah Downie and Selectman Ben Tamsky. Town Attorney Jeffrey Londregan was also present.

First Selectman Chesebrough asked all to stand for the Pledge of Allegiance. She then asked for nominations for Moderator. Selectwoman Downie nominated Eric Janney and being properly seconded by Selectman Tamsky, Mr. Janney was unanimously elected Moderator of the meeting. Town Clerk, Sally Duplice served as Clerk.

The Moderator described how the Town Meeting will proceed. Everyone must check in, show identification and be either an elector or a citizen qualified to vote in Town Meetings in order to receive a paper ballot. For the two (2) items on the agenda for which a vote is being taken, the voting will occur immediately following the discussion of the two (2) items being considered and will be tallied and the results announced.

Without objection, the Moderator dispensed with the reading of the Call of the Meeting recorded immediately preceding this page. The Moderator, without objection, dispensed with the reading of the full text of the FIRST item on the Call of the Meeting (see full text of Resolution 1, Deed to property, at end of minutes). The First item on the Agenda is a Resolution To consider and vote on a resolution to authorize the purchase of certain real property located on Noyes Avenue, and commonly known as "the Circus Lot," from the Town of Westerly for Thirty-Five Thousand Dollars (\$35,000) as provided for in a certain deed recorded in Volume 236, Page 349 of the Town of Stonington Land Records; and to further authorize the First Selectman to sign any and all documents necessary and incidental to effectuate said purchase.

For the purpose of discussion, the Moderator asked for a motion to approve the Resolution. Motion to approve was made by Selectwoman Downie and seconded by First Selectman Chesebrough. The motion passed unanimously.

Before opening the floor to discussion, the Moderator called on Chad Frost, Landscape Architect, to give an explanation of this resolution. Chad gave a slide presentation depicting the land and surrounding areas as well as possible uses for the lot. The Moderator then opened the floor to discussion. Hearing none, the Moderator reminded the audience that the vote will be taken after all resolutions are heard. Participants must be checked in and verified to receive a paper ballot.

Without objection, the Moderator dispensed with the reading of the full text of the SECOND item on the Call of the Meeting (see full text of Resolution 2 at end of minutes). The Second item on the Agenda is a Resolution To consider and vote on a resolution to adopt an Ordinance of the Town of Stonington, Connecticut, establishing a Cemetery Commission.

For the purpose of discussion, the Moderator asked for a motion to approve the Resolution. Motion to approve was made by Selectwoman Downie and seconded by Selectman Tamsky. The motion passed unanimously.

Before opening the floor to discussion, the Moderator called on Elizabeth Wood, Executive Director of Historic Stonington, formerly Stonington Historical

Society, regarding this resolution, which she briefly discussed. The Moderator then opened the floor to discussion. Kyle Berg came forth and stated that he is the President of the Board of Stonington Cemetery Association and he would like to propose amending this resolution. Under the fourth (4th) "WHEREAS", second (2nd) and third (3rd) lines, he would like the wording "as well as taking the lead in" and "including those owned" to be changed to "as well as collaborating in" and "excluding those owned". Attorney Londregan reviewed the wording of the Ordinance establishing a Cemetery Commission with these proposed language changes and determined that they would be acceptable. Upon motion to amend the resolution and properly seconded by James Davis, the Moderator asked for a vote on the resolution as amended by a show of hands for all who were in favor and all who were opposed. The "ayes" overwhelmingly outnumbered the "nays".

With no further discussion on the floor, the Moderator recessed the meeting at 7:30 p.m. to allow for a vote on the two (2) Resolutions moved and seconded by this Town Meeting. Electors and citizens qualified to vote in Town Meetings came forward to cast their vote by paper ballot for the two (2) items on the Call of the Meeting and then returned to their seats. When all the ballots were collected, Town Clerk Duplice and Executive Administrative Assistant, Stacey Haskell, tallied the votes.

At 7:50 p.m. the Moderator reconvened the meeting to announce the results of the voting for each resolution as follows:

First Resolution:

Yes - 146 No - 10

Second Resolution:

Yes -144 No -10

The Moderator declared the Resolutions as passed.

There being no further business on the Call, the Moderator asked for a motion to adjourn. Motion was made by Selectwoman Downie and seconded by Selectman Tamsky. The motion passed unanimously and the Moderator declared the meeting adjourned at 7:53 p.m.

Stonington Cemetery Commission Ordinance

WHEREAS, the Town of Stonington wishes to establish a procedure to oversee the protection, preservation and maintenance of cemeteries in the Town of Stonington; and

WHEREAS the Town of Stonington recognizes the need for a coordinated, collaborative approach to address the issue of maintaining Stonington's historic, public cemeteries; and

WHEREAS the Town of Stonington wishes to establish a Cemetery Commission to serve as an advisory body to the First Selectman, and as a center of communication, with the objective of ensuring Stonington cemeteries are respectfully cared for, maintained and documented; and

WHEREAS, the Town of Stonington desires to establish a Cemetery Commission that will be done in accordance with the Connecticut General Statutes, Chapter368j, as well as taking the lead in recording data for all cemeteries, including those owned by cemetery associations or Ecclesiastical Societies, in accordance with Connecticut General Statutes Chapter 93, Sec. 7-71.

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE LEGAL VOTERS OF THE TOWN OF STONINGTON IN LAWFUL TOWN MEETING DULY ASSEMBLED THAT:

Section 1. That the Code of Ordinances of the Town of Stonington be amended by adding a new ordinance to read as follows:

- **A. Establishment**. The Town hereby establishes a Cemetery Commission.
- **B. Purpose.** The Cemetery Commission will serve as an advisory body to the First Selectman, and as a center of communication, with the objective of ensuring Stonington cemeteries are respectfully cared for, maintained and documented.
- **C. Terms of Office.** The Commission shall be composed of five (5) regular members and two (2) alternate members who will serve staggered three-year terms. Regular and alternate members shall be appointed by the Board of Selectman. The initial appointments by the Board of Selectmen shall be for one-, two- and three-year terms, and thereafter all terms shall be for three years.
- **D. Membership.** All Commission members and alternate members shall be electors of the Town of Stonington. The Commission should have diverse representation. When possible, preference should be given to ensure membership includes: a historian, a Veteran or Veteran's representative, a member of the Conservation Commission or a landowner with a cemetery that lies within the landowner's boundaries. Seats should be given to those who will help ensure the balanced and diverse views needed to address cemetery needs within the Town of Stonington.
- E. Powers and duties. The Commission shall, among other things:

- I. Work in a collaborative manner to evaluate, define and monitor the needs of cemeteries within the Town of Stonington.
- II. Work with the Department of Public Works and the First Selectman to prepare a maintenance plan for all cemeteries owned by the Town of Stonington.
- III. Make recommendations for updating records as necessary.
- IV. Work with other town Departments and Commission as appropriate on matters related to cemeteries, for example, working to ensure that the Town's approximate 120 acres of cemetery land is identified and catalogued.
- V. Monitor State of Connecticut legislation and regulations relevant to cemetery ownership, care and maintenance. When applicable, work with the Board of Selectmen on outreach and advocacy related to relevant public policy.
- VI. Monitor the availability of grants, programs, partnerships and other resources to support the perpetual care of the Town's cemeteries.
- VII. Working with Historic Stonington, develop and maintain a program of public engagement, communication and education on the topic of cemetery maintenance, including gravestone maintenance and care.
- VIII. Other responsibilities relevant to cemetery maintenance as determined by the Department of Public Works and First Selectman.

Section 2.

- A. All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.
- B. This ordinance shall become effective fifteen (15) days after the date of publication or notice of its passage, per Connecticut General Statute 7-157 (a).
