 - Provided a proposal for an extended payment plan for hook up charge for consideration by the WPCA copy in Mtg minutes file.
- b) Harry Boardsen Noank Shipyard
 - This was a carryover from the March WPCA Board meeting. Mr. Boardsen had requested consideration for two issues.
 - Consideration for reduced hook up charge based on prior grinder pump station hook up for seasonal bathroom facilities. Denied by WPCA Board at March meeting based on requirements of Regulations.
 IF Noank Shipyard had paid a hook up charge for the 2006 grinder pump station hook up (but did not), that amount would have been credited to this new change of use hook up charge.
 - Extended payment plan for hook up charge requested
- c) Discussion by WPCA Board

A draft of a new regulation providing for an extended payment plan for hook up charges was reviewed by the Board. R. Cody to work with WPCA Director to revise the draft to include;

- · Term: 7 years
- Rate: Prime plus 1% fixed at the time of Permit.
- Payments: Further review two approaches (a) 10% up-front and 6 equal payments (including interest on outstanding balance) due on or before July 1st of each Town budget fiscal year, or (b) 7 equal payments.
- Accelerate payment if property in foreclosure.
- Remove requirement for full payment upon property sale.
- · Make Regulation effective upon passage by WPCA Board.
- Public Notice and a Special meeting to be scheduled for Public Hearing and WPCA Board action when new Regulation prepared.
