The meeting was called to order at 7:00 PM.

7:00 PM: Public Hearing

- a. **ZBA #23-11 Berstev LLC** – Seeking a variance from ZR 5.1.1 to reduce the rear yard setback from 5' to 0' and increase the floor area ratio from 50% to 88% to construct a wood storage area and to cover existing smokers. Property located at 4 Roosevelt Avenue, Mystic, CT 06355. Assessors Map 174 Block 17 Lot 4; Zone LS-5. ***Continued from 11/14/2023***

Josh Feldman presented the Board with an additional site plan showing 3 feet and 1-foot setbacks for the smoker cover and wood storage cover.

The Board discussed various types of covers for the smoker and the difference between a deck and a patio. Discussion ensued regarding if the wood cover structure should be flush with the fence or a one-foot separation. The concern being that the one-foot separation would be a catchall for debris.

Public hearing closed at 7:21 pm.

Motion made by Mark Bancroft and seconded by Diana Lurie Boersma with stipulations:

1. Smoker shelter is limited to 13' x 14' or 182 SF maximum.
 2. Smoker shelter is to be an open air, pavilion style structure – no sides on structure.
 3. Smoker shelter setback is reduced to 3 feet.
 4. Wood Storage structure is reduced to 0 feet.
- b. **ZBA #23-14 Harry Emanuel Calmar & Margarete Calmar (Arthur H. Hayward Jr., Agent)** – Seeking a variance from ZR 5.1.1 to reduce minimum lot size from 120,000SF to 25,113SF. Property located at 66 Collins Road, Stonington, CT 06378. Assessors Map 125 Block 2 Lot 2; Zone RC-120. ***Rescheduled to 1/9/2024***

Discussion:


