The Board of Finance held a special meeting on this date at the Police Department meeting room. Members present were John O'Brien, Chairman; Glenn Frishman, Secretary; Dudley Wheeler; Bryan Bentz; Sandy Grimes and June Strunk. Also present Maryanna Stevens, Director of Finance, Selectmen, Town and SPS staff, BOE members and residents.

Mr. O'Brien called the meeting to order at 7:00 p.m.

Budget deliberations

Mr. O'Brien informed the audience that as this was a continuation of budget deliberations, there would be no comments from the public. He stated that the Public Hearing is scheduled for Thursday, April 10, 2014 at 7:00 pm in the High School auditorium.

Last year the Town used a portion of the fund balance to minimize the tax increase, last night at the Town meeting \$1.2 million was taken from the fund balance for repairs to Deans Mill School, this ensures there will be no net tax increase but these funds are not available.

He added that after polling the Board members, it was agreed to reach for a maximum tax increase of .49 mills representing a 2.46% increase; the necessary cuts to attain this total \$2,193,705. The Board of Education budget as submitted represents 76% of the increase. With regard to the School Safety items in the CIP, Mr. O'Brien suggested a separate budget that will be submitted at Town meeting and the Town could bond, as these are capital investments. He added that he has spoken with the First Selectman regarding necessary cuts from the General Government budget. The Grand List did not improve but within three years with new projects coming on this should change.
