Discussion - Adjustment to Donahue Park Hours

Donahue Park currently closes from 10:00 p.m. to 6:00 a.m. An adjustment of the hours to closing from sunset to sunrise would align the park to be consistent with the other parks/playgrounds that are overseen by the Human Services Recreation Department. Exceptions to the usage of the park for special events that will occur during regular and off hours will continue to go through the Town's permitting process which is overseen and approved by the Board of Selectmen.

A motion was made by Ms. Downie, seconded by Ms. Strunk and voted unanimously to adjust the hours of Donahue Park to being closed from sunset to sunrise.

Discussion – Creation of Permanent Affordable Housing Committee vs. Creation of Affordable Housing Task Force

Discussion ensued regarding the formation of a permeant committee being formed vs. a task force. All Board members shared their thoughts and were in agreement to the creation of a permanent committee. The Board members also discussed holding community conversations prior to sending to a Town Meeting for approval as there was much interest by the community in the creation of this committee. It was also noted that it will take some time to research and prepare the draft of the committee formation to include membership, terms, power and duties.

Award of Bid - Mystic River Boathouse Park Remediation Consultant

A Request for Proposals for the Mystic Boathouse Park Brownfield Remediation was issued and a site walk was held in March. Four firms attended the site walk. The Planning Department received one (1) bid for the Mystic River Boathouse Park Remediation Consultant on April 14, 2022. The proposal was rated and ranked by the review panel according to the criteria outlined in the request. The Planning Department requested that the award go to AECOM for a maximum of the \$753,889 funded by the DECD Brownfield Remediation Grant. The selected firm will work with the Town as the site Licensed Environmental Professional (LEP) to plan, monitoring and guide remedial actions, documentation, and compliance with CTDEEP Voluntary Remediation Program

A motion was made by Ms. Downie, seconded by Ms. Strunk and voted unanimously to award the bid for the Mystic River Boathouse Park Remediation Consultant to AECOM for a maximum of \$753,889 to be funded by the DECD Brownfield Remediation Grant.

Discussion - Rescind CGBG Consulting Contract

The Town was informed that the Stonington Housing Authority will not be pursuing a CDBG application this year. Therefore, the award for the CDBG Consulting Contract with Eastern Connecticut Housing Opportunities will need to be rescinded.
