The meeting was called to order at 6:05 p.m. by Dave Hammond, Chairman.

Introductions: Roundtable.

Elsie thanked Zest Fresh Bakery for their donation of treats for tonight's meeting, along with a contribution of the Economic Development Commission. She then reviewed a status report which was emailed prior to this meeting. The topics covered were: Composition of interested participants, Outreach, Tasks and Municipal preparation.

Wendy and Danielle gave an update of the municipal process. There will need to be a Town Meeting which takes 6-8 weeks to prepare and give all proper notices. Discussion on potentially scheduling the meeting with vote in January 2023. Wendy gave an overview of the state's outlook. Wethersfield is the fourth Cultural District approved. There are about 14 others in the "works". Discussion on broadening our application to two districts which would be the Stonington side of Mystic, including the Seaport south to Route 1. It was agreed that this was a comprehensive approach and the two districts offer variety and a rich cultural experience.

Discussion on next steps: Discussion on getting more participants to attend the meetings and work together on project tasks. Paul offered to remind contacts and encourage participation. Matt will begin the new map.
