FINAL MINUTES

Regular EDC Meeting Wednesday, October 11, 2022 6 pm SPS District Office Board Room, 40 Field St, Pawcatuck, CT

Attending: EDC: Kevin Bowdler, Jim Lathrop, Suzanne Lane, John Godin, Elsie Bisset; Don Fiore, Virginia Abernathy, Derek Johnson, Bill Hobbs, Cullen Hagan. Also present was Susan Cullen

The meeting was called to order at 6:03 pm.

Minutes were approved for Regular meeting, September 13, Special Meeting – Cultural District September 20 and Special Meeting – Energy Fair October 5th. Motion by Kevin Bowdler, seconded by John Godin. All in favor.

New Business. (a) Approved the regular meeting schedule for 2023 to be the second Tuesday of each month at 6 pm and to be held at the SPS District Office Board Room, 40 Field St, Pawcatuck. Motion by Kevin Bowdler, seconded by John Godin. **All in favor**.

The next EDC meeting clashes with the Election where some members are volunteering, and others are away. It was agreed that we would cancel the regular meeting for 11/8 and hold a Special Meeting on Tuesday 11/15 at SPS District Office (Room TBD), 40 Field St, Pawcatuck, CT. Motion by Elsie Bisset, seconded by Don Fiore. All in favor.

Jennifer Lineweaver plans to hold a Community Conversation about the Property Revaluation Process 2 to 3 weeks prior the letters being mailed to homeowners. (November or December). The EDC discussed ways to advertise the event so that Stonington homeowners can understand the process and the impact on their taxes.

EDC Priorities were discussed, and the attached spreadsheet has been updated. A few noteworthy comments are mentioned here; The Gateway project will be on a temporary hold. Elsie Bisset and Derek Johnson will work on this initiative after the Cultural Districts project is complete. The Cultural District sub-committee is looking at 2 districts. One in Stonington Borough and another in Mystic that starts at the Seaport and runs south towards downtown Mystic.

EDC would like to issue 8 to 10 email blasts from Stonington1649.com per year covering relevant economic development news. A motion was made by KB to pay \$250 to Thomas Mitchel or other qualified person to compile content, format and distribute each newsletter. Seconded by John Godin. All in favor.

A sub-committee of EDC and the Stonington Climate Change Taskforce has been meeting to co-sponsor an Energy Fair on March 25, 2023, at the Mystic Aquarium Research center. The goal would be to provide knowledge to Stonington residents and business owners about

various alternative energy options available and the government incentives associated with these investments. We will have keynote speakers and we will have panels of residents and business owners who have invested in Solar, Geothermal, batteries and heat pumps as well as vendors and installers of such products. We will also have EV's, electric bikes, power tools etc. on display. A motion was made by KB to issue a press release announcing the Energy Fair on March 25, 2023, and request expressions of interest from vendors who would like to be invited and who would pay some nominal fee to attend. The fee would go towards marketing the event. Seconded by John Godin. **All in favor**.

Other new business. The POCD Implementation Committee meets periodically and the EDC needs to have a representative at the meetings. Virginia Abernathy agreed to attend on behalf of EDC.

Susan Cullen updated the EDC re the Comprehensive zoning update meeting, the sidewalks initiative, Stillman Ave Mill, and the Mystic Boathouse projects.

No public comment.

Meeting adjourned at 7:53 pm.
