### MINUTES:

A motion was made by Resident Commissioner Lee and seconded by Chair Careb to approve the minutes of the September 9, 2021 regular meeting. Motion passed 3-0-0.

## READING OF THE TREASURER'S REPORT:

ED Phylicia Adams presented the Treasurer's report as of September 30, 2021, showing a balance of \$17,132.37 in the Berkshire Bank checking account; \$3,627.43 in the Berkshire Bank Pet Deposit account; for total cash operations in all Berkshire accounts of \$20,759.80. A total of \$339,431.98 for savings and investments and \$128.32 in petty cash. The total of all savings and checking assets is \$360,320.10.

OLD BUSINESS: There was no Old Business to report on this month.

### **NEW BUSINESS:**

- 2022 Budget Discussion: ED Adams presented the 2022 Budget to the Board of Commissioners referring to each line item expense as compared to 2021. Vice-Chair Savin recommended a segregated reserves account. She would like to see the amount in reserves increase to \$500,000.00. Chair Careb agreed with Julie to maintain an amount of \$500,000.00 in reserves. Careb asked ED Adams to modify the budget to work on pre-development grant money to pay for a consultant. Chair Careb made note that SHA will not pay for a consultant unless we have the funds to pay for one through a grant source. After further discussion Chair Careb made a motion to approve the 2022 budget with edits suggested by her and Vice-Chair Savin. Vice-Chair Savin seconded the motion. Motion approved 3-0-0.
- 2022 Board Meeting Schedule: ED Adams proposed to the Board to schedule the 2022 meetings every other month beginning in January 2022. A motion was made by Chair Careb to move Board Meetings in 2022 to every other month beginning in January 2022 and if any issues come up an emergency meeting can be scheduled. Motion was seconded by Vice-Chair Savin. Motion passesd 2-1-0.
- Transfer Pet Deposit Funds: ED Adams proposed to transfer the Pet Deposit Savings account from the Berkshire Bank to the Liberty Bank Escrow account. Vice-Chair made a motion per ED Adams' suggestion to make that transfer. Resident Commissioner Lee seconded the motion. Motion passed 3-0-0.

### PUBLIC COMMENT:

Resident Commissioner Lee brought up a discussion about a resident who was charged to replace a broken toilet. ED Adams explained that things that are damaged outside of normal wear & tear are billed to the tenant. She stated SHA has to have a plan in place to recoup those expenses.

Resident Commissioner Lee also brought up some concerns from absent tenant Donna Haggerty. Her first concern was regarding her discontent that the previous meeting she attended had been cut off from Zoom. Her second written comment was that she'd like the internet on 24/7 in the community room. ED Adams explained there was an issue one day the previous week with the internet being out. This was a Comcast issue.

Haggerty also wanted to know what the utility allowance means on the yearly rent calculation work sheet. ED Adams explained that every tenant receives this discount on their rent.

Resident Commissioner Lee also brought up a few maintenance issues from Haggerty. She also stated that Haggerty wants the tattered American Flag replaced. Chair Careb told Lee to let Haggerty know she needs to fill out her maintenance requests on the work order forms.

ADJOURNMENT: A motion was made by Resident Commissioner Lee and seconded by Chair Careb to adjourn the meeting at  $5:17 \, \text{p.m.}$  Motion passed 3-0-0.
