To present the itemized estimates of expenditures of the Town for Fiscal Year 2021-2022 as recommended by the Board of Finance and to hear the citizens of the Town in regard to any appropriation which they are desirous that the Board recommend or reject. Based upon the above recommendation the estimated level of taxation for Fiscal Year 2021-2022 is at 23.85 Mils. Of the above budget, the amount to be raised by taxes is \$67,410,306.

You should cite the area of the budget you plan to comment on and if you are in favor or opposition.

<u>Secondary Option</u> - Residents wishing to speak during the public hearing must dial into the meeting. The Board will review each item of the budget by section. When the area you wish to comment on is announced press \*3 to "raise your hand". When it is your turn to speak you will hear a prompt telling you to press \*6 to unmute your line. At that time, you are able to speak in the meeting. Residents will be limited to two minutes in comments.
