**RE:** Suspense List

Attached please find the Suspense List for 2022. As you are aware, suspended accounts are still collected for 15 years from the date first due and continue to accrue interest during that period of time, but are placed on this list if they are determined to be uncollectible by the usual methods of collection. The motor vehicle and personal property suspense accounts are now forwarded to Rossi Law for collection.

Also, please note that the Real Estate suspense accounts are for mobile homes that have been moved from lots in town. Per state statute mobile homes are taxed as real estate and not as motor vehicles or personal property. State Statutes were recently changed to allow suspended real property if the tax is deemed uncollectible and will include tax for such things as paper streets and small strips of property which the town also does not want.

To Whom It May Concern:

Enclosed please find your list of accounts for Suspense. Suspended accounts are those which we consider uncollectible either because we have had mail returned or the tax payer is deceased or bankrupt. (Real Estate taxes in suspense are for mobile homes which have been removed or the liens have been expunged by the court. Statutes were changed this year to also allow Suspense for real property which is deemed uncollectible such as open space or paper streets.)

Taxes (including all interest) are collectible for 15 years from the date first due per Connecticut State Statutes. However, when an account is in the Suspense file we do not continue to send notices or actively try to collect those accounts in our office. Motor Vehicle accounts which have had mail returned are forwarded to our collection agency, Rossi Law, for collection.

Please sign the enclosed form and return to us in the enclosed envelope as soon as possible so that any accounts which should be sent to Rossi can be forwarded. If you have any further questions, please let us know.

## SUMMARY

The Public Works Engineering Division currently manages the Town of Stonington Pump Out Boat Program which provides service to Stonington Harbor, Little Narragansett Bay, Pawcatuck River and Watch Hill Harbor. The program is funded in part (75% reimbursement) from a Connecticut DEEP grant and Town of Stonington (25% match in kind). The program runs from May 25 – October 14 and operates six days a week. The program collects and legally disposes an average of 50,000 plus gallons of recreational boating vessel wastewater each season.

The Marine Sewage Disposal Facility pump (circa 2011) has reached its life and requires replacement. The estimated cost for replacement is \$23,113. Connecticut DEEP will reimburse the Town 75% of the original project estimate. Therefore, the direct cost to the Town shall be approximately, \$5,463.
