#### **MEETING PROCEDURES**

#### **PUBLIC HEARINGS**

Public hearings are an opportunity for public participation during the review of a development proposal.

Applicants will make an initial presentation. The public can then speak "in favor," "in opposition," or under "general comments." A signup sheet is located at the main entrance. Participants are not required to sign up, however, the list will be used to organize the order of interested speakers.

Any questions will be addressed as part of the applicant's rebuttal. Once a public hearing has been closed, neither the applicant nor the public can participate in the proceedings.

#### **NEW SUBMITTALS**

No action will be taken on these items. New submittals require routing to other town agencies, and in some instances will be scheduled for a public hearing at a later date.

## 8. Public Hearing(s):

- A. PZ1921SUP Thirty Eight, LLC (S. Nousiopoulos) Special Use Permit application to permit residential mixed-use in an existing commercial structure (ZR 6.6.21). Proposal is for an approximate 1,000SF one-bedroom dwelling unit. Property located at 38 East Main St., Mystic. Assessors Map 174 Block 18 Lot 13. Zone LS-5.
- B. **PZ1923ZC 1189 Pequot Trail, LLC (R. Valenti)** Master Plan Zone Change application from the existing GBR-130 zone to the Agricultural Heritage District (AHD) zone. The proposed master plan seeks to preserve the farm and buildings and to stimulate economic activity by creating a campus for agriculture, livestock, equestrian activities, education, and events. The subject site, the former Dean's Mill Farm, is located at 1189 Pequot Trail, Stonington, CT. Assessor's Map 135 Block 2 Lot 1. Zone GBR-130.
