The Stonington Board of Selectmen held a regular meeting on this date at the Stonington Police Department at 5:30 p.m. Present were First Selectman Danielle Chesebrough, Selectwoman June Strunk and Selectwoman Debbie Motycka Downie.  collaborate. Further, she gave an overview of additional meetings she attended including Planning
 and Zoning Commission, Board of Police Commission and Recreation Commission.

The Veteran Monument Project continues to move forward and actively seeking any veteran who called the Town of Stonington home to ensure they are listed on the monument.
