They meet all the needed insurance requirements by the Town.

(11) Comments from the Selectmen

- Ms. Downie noted that the projects with Stillman and Mystic River Boathouse Park continue to move forward. She also thanked those who sponsored the parade held on Labor Day.
- Ms. Strunk stated that affordable housing projects can apply for state funding to offset construction costs. In the case of the Campbell Grain project the Town has to provide a local match to allow the developer to apply for the state funding. She noted that the project went through several different boards/commissions to obtain approvals. The minutes of which can be found on the town website. Ms. Strunk asked if it was possible to publish the routing sheets that Planning and Zoning has created to help the public to follow along with project as they move through the approval process.
- Ms. Chesebrough noted that she met with members of Human Services, Clergy, Police and area non-profits to discuss homelessness and issues within Donahue Park. In regards to Covid, weekly meetings with other municipalities continue. A mask mandate remains in place indoors at all municipal buildings. The Town continues to recommend that local businesses/restaurants, etc. encourage masks use while indoors. The Special Olympics will hold an opening ceremony of their regatta on Saturday, September 11, 2021 at the Wadawanuck Club.
