

# Stonington Harbor Management Commission Special Meeting

#### 1. Call to Order:

#### Harbormaster Report October 14, 2019

New Mooring permits issued: 0 (East Side)

Moorings being given up (this month): 0

New Mooring assignments in the works: 0

Deposits to SHMC account since last report: \$1437.20

2020 YTD = \$ 25717.20

CT DEEP approved addition of a buoy (private aid to navigation) at end of rock groin at tip of Pawcatuck Point (Osbrook Point). Waiting for permit to be issued. DEEP preferred a buoy be installed instead of a piling.

CT DEEP did not approve a permit for the private channel markers that have been annually deployed by Dodson Boatyard for the inner harbor. The reason was that once the channel markers were moved to a position where no mooring swing circles crossed into the channel it would only be approx. 50 feet wide. They have requested the markers be removed and not installed next season. It was also their suggestion that we go through a season without the markers to see if they are really needed. The other option discussed was use of mid-channel markers.

CT DEEP pointed out that the lettering is incorrect on our four SNW buoys in harbor entrance. The word 'SLOW' should be inside the diamond. Ours have 'Slow' above the diamond and 'NO' in the diamond. He asked that this be corrected.

SNW sign on Sandy Point will need to be taken down in near future.

#### Robert G

Fuel gauge has been replaced. Sender unit was functional. All now in good working order.

Expect to haul boat in early mid November (once the harbor is clear of most moored vessels. Boat will be stored at Don's Dock again this year unless arrangements can be made elsewhere.
