 interest. Cyndi will be looking at new ways to bring experiences into the community rather than
 going out.
 - o Additionally the following was reported
 - 30 residents attended the Friday lunch and Learn
 - 5 residents attended the program on naturopathic healthcare
 - Social service report
 - Choices counseling sessions have begun
 - The human services department served 162 residents in September, 130 were age 55(+).
 - 88 Energy Assistance applications have been completed. This is the highest number, as of this date, in recent memory

 - o There has been a request for the Pawcatuck Neighborhood Center to join the COA
- Senior Providers Network quarterly meetings have resume
- Legislative update
 - o No legislative updates were available.
