Resolution - Emergency Management and Homeland Security

The resolution authorizes the First Selectman to enter into, execute and deliver documentation regarding the Emergency Management and Homeland Security Grant programs.

Request - Additional Appropriation to Repairs and Maintenance Account for Department of Public Works

The Department of Public Works is requesting an additional appropriation in the amount of \$125,000 to the repairs and maintenance account to fund repairs needed for the DPW fleet and equipment. This item will also go before the Board of Finance.

(9) Comments from the Selectmen

- Ms. Downie stated that the Facilities Committee received a proposal for the possibility of adding affordable senior/varied abilities housing at the 49 N. Stonington Road property. Ms. Downie will follow up with the Chair of the committee to discuss further. She also noted that the WPCA has discovered and is correcting a broken pipe in Old Mystic that was allowing water from the river to enter the sewer system. Ms. Downie gave an overview regarding the Westerly Library Board meeting.
- Ms. Strunk gave an overview of meetings she attended including the Planning and Zoning Commission and Police Commission. She noted that the public hearing held at the Planning and Zoning Commission in regards to the Lattizori property was well received but was continued to allow for additional information to be presented.
- Ms. Chesebrough stated that the agreement for solar at the Transfer Station is getting close to being completed and added that the company, Titan, will also be looking to collect data at the schools and WPCA to see if there is a possibility to add solar. She noted she had a great meeting with members of the Town of Greenwich's Planning and Zoning Commission regarding affordable housing and sustainable landscaping. Lastly, a reminder of the upcoming Stonington Veterans Monument fundraiser that will be held at Saltwater Farm Vineyard on November 24, 2021 from 5:00-7:30 p.m. which will include many raffle prizes to benefit the project.
