# Call to Order

Commission Members were introduced.

Minutes of the Regular Meeting on November 5, 2020, were reviewed. Mr. Cook made a motion that they be approved. Mr. Carreau seconded the motion, which all approved.

Harbor Master(s) Report: (given to Chairman Carreau to present to the Commission)

Derelict Boat Beached on Mystic YMCA Property: The YMCA will become the owner on December 7. Harbormaster Procko will coordinate removal with the Town.

The Harbormaster reported that he attended the Amtrak Moveable Bridge meeting. There are no upcoming projects that will disrupt boat traffic in Mystic.

He attended USCG Long Island Safety Forum on November 16. Discussions included the large number of boats still in the water. He met John Atlund, a new Head Engineer for USAC in our district, and John Henshaw, the new director of the Connecticut Port Authority. The Harbormaster offered to forward minutes of the meetings to those interested.

The black sailboat mentioned last month has moved to Seaport Marine. Harbormaster Procko contacted Harry Boardsen for owner information.

The Harbormaster will begin revisions and updates to the Moorings Database.
