New Business:

IW #15-02 Mystic River Square Condo Association (owner); Toll CT Limited Partnership (applicant) – Seeking permit to extend the storm drainage system from its detention basin at Old Mystic Estates to Whitehall Pond, install a new outlet structure in pond & connect it to a discharge point at the Mystic River. Property located at 12 Michelle Lane, 102 Whitehall Ave. & 6 Whitehall Pond. Assessor's Map 165 Block 3 Lots 1A & 2 and Map 148 Block 3 Lot 3B. Zone GC-60, RR-80 & RH-10.

Old Business:

IW #15-01 Roy Jarvis, owner; Pierce Hall, applicant – Seeking a permit for construction of a single family residence with town sewer and water connection, driveway and related site improvements with the upland review area. Property located on Maple Street, Lord's Point. Assessor's Map 130 Block 9 Lot 2; Zone RM-20.

Application was made in 2009 by Roy Jarvis but never completed Ms. Palmer informed the commission Scott Deletta was the engineer for the application in 2009, no issues with plan, issues with the Lords Point Association prior, currently no comment. The commission questioned whether the driveway could be completely gravel.
