1. Call to Order:

I have given USCG the old NY registration number and names and phone numbers I found on board. USCG will follow up on trying to locate owner. Boat is in RI water, so RI DEM will need to be contacted. There is no sheen coming from the boat at high tide.

Ed Smith reported the transient float at Stonington Commons needs repair to one of the piling hoops. Stonington Commons needs to be contacted about this issue.
