Chris Kepple representing the Stonington Historical Society requested funds to meet their Lighthouse Restoration project. The Committee changed the request to B/Urgent.

Belinda DeKay and Micayla Hall spoke regarding the Stonington Free Library request for funding to help offset the cost of the ADA Compliance. The project is committed and given a status of A/Committed, with more discussion to follow.

Being no further business, the meeting was adjourned at 12:30 pm.
